E-tender is invited under Two-bid system from bona-fide, resourceful and experienced PSUs/contractor firms with sound financial health, in prescribed format, by the Registrar on behalf of SNBNCBS for “**Renovation of Room No.-104, Main Building including Miscellaneous External Works**”. 12. **Qualifying Criteria:**
 - i. Firms should have relevant experience of having successfully completed similar works in any of the last five years. Minimum single work order value should be Rupees 3 lakhs or for two similar works value Rs 2.0 lakhs each or three similar works value 1.50 lakhs each.
 - ii. Firms should have working experience with CPWD / State PWD / MES / Railways / BSNL / Reputed Central or State PSUs /Autonomous Body.
 - iii. Average annual financial turnover during last 3 (three) years ending 31.03.2017 should be minimum of Rupees 20 lakhs by giving a self-certificate. Firms should furnish last three years’ IT return. However, in case of gross mismatch between the self certificate and the IT return records, the offer may be liable to be cancelled.
