## NOTICE INVITING E-TENDER

E-tenders are invited under Two-bid system from bona-fide, resourceful and experienced agencies in prescribed format by the Registrar on behalf of SNBNCBS for “**Day to Day Maintenance & Housekeeping of Main Building, Nano Fabrication Lab, Mechanical Workshop, Furnace Labs, Security Blocks, Spectra Raman Lab, Liquid Helium Plant and Laboratory Building-2 at SNBNCBS**”. Firms satisfying the following criteria may apply in the format given at **Annexure-I** along with relevant documents and testimonials.

1. **Name of Work** : **Day to Day Maintenance & Housekeeping of Main Building, Nano Fabrication Lab, Mechanical Workshop, Furnace Labs, Security Blocks, Spectra Raman Lab, Liquid Helium Plant and Laboratory Building-2 at SNBNCBS**
2. **Time of Completion** : Initially for 12 (Twelve) months
3. **Estimated Cost in Rs.** : **Rs.39.00 Lakhs** (Rupees Thirty Nine Lakh only)
4. **Earnest Money Deposit (EMD)** : **Rs.78,000.00/-** (Rupees Seventy Eight Thousand only) in the form of Demand Draft/ Bankers Cheque in favour of “S. N. Bose National Centre for Basic Sciences”, payable at Kolkata or valid MSME Certificate.

11. **Hard Copy submission** : The cover containing hard copy of original EMD or copy of valid MSME certificate and Annexure-I duly signed with seal and other documents in support of credentials that the tenderer wishes to submit. The envelope should be superscripted with the Name of Work, Tender Ref. No., Contact details of the agency etc.

### 12. **Qualifying Criteria:**

The agencies shall be considered as eligible for the job based on the following criteria and documentary evidence furnished:

- (a) The bidder should have minimum 3 years of experience within last 7 years up to March, 2019 in providing similar type of services in reputed Govt. organisations / Educational Institutes / Hostels / PSUs / reputed private organisations with at least one completed job of value not less than Rs.31 lakh (Rupees Thirty One Lakh only) per annum for single work order or at least Rs.20 lakh (Rupees Twenty Lakh only) or more per annum for two work orders or at least 16 lakhs (Rupees Sixteen Lakhs only) or more per annum for three work orders.

**Definition of similar work(s):** Similar works mean all kinds of man power supply works under Annual Maintenance Work for a minimum contract period of 1 (one) year.

- (b) The average annual turnover of the bidder shall be minimum of Rs.1.50 Crore (Rupees One Crore Fifty Lakh only) per annum during the last three financial years.
- (c) The bidder should possess valid Trade License and provide Registration Certificate of EPF, ESI, GST, Professional Tax, PAN etc.
- (d) The agency should preferably be Kolkata based or should have a well established administrative set-up in the city.

13. The agency may not be considered to be eligible if it has incurred substantial losses in last three years consecutively till 31.03.2019, as per the submitted documents duly certified by a Chartered Accountant. The agency should not be under liquidation, court receivership or similar proceedings.
14. This may be noted that mere fulfilment of the above criteria may not automatically qualify an agency as the final selection which will be based on past satisfactory performance with other clients, feedback from them about capability and integrity, if enquired upon by the Centre.
15. The Centre, if desires, can make site visits for the works completed by the agencies whose documents will be found ok during technical evaluation to assess the quality of the work and also to gather feedback from the client about the satisfactory performance and dealings of the agency. Adverse report from the client may disqualify the agency from opening of price bid.

The notification of award of contract will be made in writing to the successful tenderer by the Centre.

The Centre may summon the bidders for the verification of original documents during any time before and after issuance of work order and if the document is found to be false, fabricated or forged, strict action will be taken against the agency by cancellation of tender/work order and forfeiture of EMD and they will be debarred from participation in all future tenders.
