MSME certificate and **Annexure-I** duly signed with seal and all other documents in support of credentials that the tenderer submits in the CPP Portal. The envelope should be superscripted with the Name of Work, Tender Ref. No., Contact details of the agency etc.

# 12. Qualifying Criteria:

The agencies shall be considered as eligible for the job based on the following criteria and documentary evidence furnished:

(a) The bidder should have experience of having successfully completed similar works during last 7 years ending 31<sup>st</sup> March, 2020 in providing similar type of services in reputed Govt. organisations / Educational Institutes / Hostels / PSUs /reputed private organisations with at least one completed job of value not less than Rs.28 lakh (Rupees Twenty Eight Lakh only) per annum for single work or at least Rs.17.50 lakh (Rupees Seventeen Lakh Fifty Thousand only) or more per annum for two works or at least Rs.14 lakh (Rupees Fourteen Lakh only) or more per annum for three works.

**Definition of similar work**(s): Similar works mean all kinds of man power supply works under Annual Maintenance Work for a minimum contract period of 1 (one) year.

- (b) The average annual turnover of the bidder shall be minimum of Rs.1.5 crore (Rupees One Crore Fifty Lakh only) per annum during the last three financial years ending 31<sup>st</sup> March 2019 (considering the present pandemic situation).
- (c) The bidder should possess valid Trade License and provide Registration Certificate of EPF, ESI, GST, Professional Tax, PAN etc.
- (d) The agency should preferably be Kolkata based or should have a well established administrative set-up in the city.

- **13.** The agency may not be considered to be eligible if it has incurred substantial losses in last three financial years consecutively till 31.03.2019 (considering the present pandemic situation), as per the submitted documents duly certified by a Chartered Accountant. The agency must not be under liquidation, court receivership or similar proceedings.
- 14. This may be noted that mere fulfilment of the above criteria may not automatically qualify an agency as the final selection which will be based on past satisfactory performance with other clients, feedback from them about capability and integrity, if enquired upon by the Centre.
- **15.** The Centre, if desires, can make site visits for the works completed by the agencies whose documents will be found ok during technical evaluation to assess the quality of the work and also to collect feedback from the client about the satisfactory performance and dealings of the agency. Adverse report from the client may disqualify the agency from opening of price bid.
