# TECHNICAL SPECIFICATION FOR 10 KVA / 8 KW STAND ALONE ON LINE UPS

#### **Technology**

- True On Line UPS with double conversion technology based with (DSP) Digital Signal Processor
- UPS should be with Intelligent Battery Management for longer battery life
- The UPS should be with input power factor 0.99
- IGBT based rectifier and inverter.
- 160 event logging in LCD Display
- Phase Reversal protection In the event of reversal in phase sequence, the UPS should automatically adjust itself and should get synchronized with the input phase without need for long discharge of battery bank.
- UPS should have Cold Start facility.

#### **Efficiency**

• Overall Efficiency including Isolation Transformer should be minimum 84% for overall AC to AC, 95% for rectifier.
